Last year's speakers and honorees blew us away and marked a new era where getting diverse boards has become an imperative reaching record numbers -- 100% of S&P companies have at least one director, 46% of the Russell 3000 director seats were women in the first half of 2019, and 20.4% of board seats in the US are now filled by women. The historic inaugural year SB826 women on boards law in California has led to a national ripple effect with 6 states having adopted or proposed amendments for gender diversity in the boardroom. And the momentum is palpable as we move into critical mass: up to 3 women on the board by next year!

How Women Lead is one of the primary actors driving the change in corporate board composition in the US. We believe, as the research confirms, the companies perform better when boards are diverse and focus on stakeholder value.

To that end, in 2020 we are hosting trainings for 300 director candidates, sharing and doing placements for board opportunities, inspiring thousands through our movement building culminating in a year-end celebration highlighting progress in the Bay Area and nationally.


